



PAYMENT

RESCHEDULE AND CANCELLATION

LEVEL 1 or similar:

Your booking and/or reservation can be cancelled with 24 hours after booking and/or making the reservation of your spot for the course. To cancel a booking, please contact us via email at accounts@tfauae.com stating your name and contact number. If after cancelling you then wish to re-instate a place a) this place cannot be guaranteed to still be available and b) you will need to book your spot making full payment.

LEVEL 2 or similar:

Your attendance booking and/or reservation can be cancelled with 4 weeks' notice before starting date of the course. To cancel a booking and/or reservation, please contact us via email at accounts@tfauae.com stating your name and contact number. Please note you need to give a 4 weeks' notice to cancel.
